## NEW DATABASE IS LIVE as of 1 January 2023!

We are excited to report that the new WakeUpSafe database is now live. **The data governance committee (David Buck, Chair; Manon Hache, Bishr Haydar, Raj Iyer, Sally Rampersad, Helen Shi, Lena Sun, Imelda Tjia, Rich Tsui, Josh Uffman, Anna Varughese)** approved the database to go-live. The committee worked with the development team led by Raj Iyer and Rich Tsui to implement improvements in

response to WUS members' comments on the beta test version which was introduced at the Fall 2022 meeting in New Orleans. The resulting database version 1.2 is now ready for patient data.

Appropriate cases from 1 January 2023 forward should be entered into the database.

We expect that during this year we will have opportunities to identify potential tweaks and improvements.

The development team and the WUS data governance committee have put in place a process to collect your suggestions and work on periodic updates.

Few important highlights from the announcement:

- The Database is live as of Jan 1, 2023, for numerator/case data.
- Institutions that wish to do so can enter data for periods before that date for their own use but those data will not be included in the WUS analyses.
- Quarterly reports from the numerator data will be pushed out regularly beginning in mid-2023.
- The proposed lock date for data entry is 30 days after the end of the quarter. The reports will be available about 45 days after the end of each quarter.
- We will aim to coordinate the deadlines to be consistent with NSQIP deadlines to make it easier for hospital staff.

# **2022** Annual Meeting in New Orleans in Brief



### **Quality Improvement Committee**

For the past several years, Wake Up Safe (WUS) institutions have implemented multiple strategies to prevent medication errors in the operating room. This past year, WUS has decided to tackle another important safety initiative, prevention

of perioperative peripheral intravenous (PIV) catheter infiltrations. Infiltrations and extravasations can lead to swelling and pain, even blisters, infection, and chemical burns 1 that could lead to patient discomfort. Injury from infiltrated IV's may even result in severe harm such as necrosis of soft tissues or compartment syndrome.<sup>1,2</sup> Aside from the physical pain, PIV infiltrations may result in emotional distress for the patient and family as well as the caregivers. Furthermore, infiltration events have the potential to incur additional hospital expenses (i.e., lengthened nursing and physician time, extended length of stay, supplies, etc.).

Using data from WUS institutions, various strategies are implemented with the aim of decreasing the incidence of perioperative PIV infiltration events. Scheduled intraoperative IV checks or programmed EMR reminders to evaluate IV sites intraoperatively have been proposed. Parental collaboration to help providers identify infiltrated IV sites and IV pump alarm adjustments are other approaches that are being explored. Institutions are employing

the use of technology for IV site monitoring. Vein visualization technology is widely used by WUS institutions and methods to optimize its use are shared during WUS discussions. With various interventions to prevent perioperative PIV infiltration events, WUS hopes to demonstrate positive outcomes and improve patient satisfaction.

#### **WUS International**

WakeUpSafe is active internationally and is creating collaborations under the leadership of Director of WUS international outreach Dr. Raj Iyer from CHOP. This activity is supported by CHOP Anesthesiology Chair Dr. Dean Kurth.

Here are the following activates that are ongoing and completed:

1. India: There are 4 hospitals in India that have obtained IRB approval to move ahead with the database entry. The test database is set up and is presently on hold due to revisions with the USA WUS database. After approval from the WUS, the new database schema will be shared with WUS India with a similar process of how the previous database was shared.

Raj met the Indian leadership in October 2022. Based on this meeting, Dr. Narayana from PGIMER, Chandigarh was identified as the main contact for the next iteration of the database for both clinical and technical aspects. The Indian leadership

Dr. Elsa Varghese is the WUS Director of India. The leadership acknowledged the extremely high and complex clinical volumes keeping the WUS hospital representatives Semi-Annual Newsletter Jan 2023 A component of the Society for Pediatric Anesthesia busy. Masimo Foundation has supported funding for this activity with Raj Iyer from CHOP as PI for this. There are ongoing conversations regarding hiring support personnel in India.

CHOP WUS was expecting Dr. Varghese and Dr. Sandhya from PGIMER to visit CHOP and US WUS hospitals. However, due to the long backlog of visa processing times, this did not happen in 2022. This will be an ongoing conversation and the Dept. of Anesthesiology at CHOP has assured us to accommodate them anytime.

Multiple faculties from WUS USA visited India and have conducted multiple workshops and lectures. The left picture is of a workshop held at All India Institute of Medical Sciences in New Delhi. This was the first part of the conference prior to the breakout session. The middle frame is a picture where Dean Kurth is discussing active collaboration with the Director of PGIMER, Chandigarh. PGIMER, Chandigarh is recognized by US News World Report as one of the best in India, Asia, and Global Universities. In the right frame, Dean is felicitated by the Indian Association for active collaboration and helped set up the first patient safety organization in India specific for pediatric anesthesia.



2. Australia and New Zealand: The SPANZA (Society for Paediatric Anaesthesia in New Zealand and Australia) is excited to have an active collaboration with CHOP and WUS in the USA. Raj lyer presented to the SPANZA leadership regarding the implementation of such a collaboration and pitched the idea of conducting a workshop at their conference. SPANZA leadership is excited to create a WUS database the first of its kind specific for pediatric anesthesia in Australia and New Zealand. The leadership invited Raj lyer and team to conduct a workshop at their National Conference in Sydney, Australia. The workshop faculty included Sally Rampersad and Elizabeth Hansen from Seattle Children's and Megha Kanjia and Imelda Tjia from Texas Children's Hospital. The below pictures are from the workshop.

3. **Singapore:** The WUS faculty had conducted a virtual workshop with the Asean Society for Paediatric Anaesthesia in 2021. This was well received. In follow-up with active collaboration, Raj Iyer was invited to KK Children's Hospital in Singapore. KK Children's is the largest pediatric hospital in Singapore and was established in 1858. In addition to providing a grand round on safety, Raj Iyer discussed ongoing collaboration with WUS with the Singaporean leadership in October 2022. - 4. European Society for Paediatric Anaesthesia (ESPA): WUS conducted a workshop at ESPA a couple years ago. However, the ESPA hospitals are in the Safety 0 and 1 phases of care and many are still learning the basics of QI and Safety Analytics. The level 3 WUS members will continue to deliver lectures at the annual meeting by invitation.
- 5. Association of Paediatric Anaesthetists of Great Britain & Ireland (APA), other local conferences in Great Britain: The level 3 USA WUS members will continue to deliver lectures at annual meetings by invitation.
- 6. **Canada**: In discussion to partner with pediatric anesthesia society like partnership with India IAPA.
